FEES INCLUDED IN TUITION

- A full-service lunch program provided by Sage Dining for grades K-12.
- The use of a school-owned student device as a part of the Connected Learning Program for students in grades 6 -12.
- A yearbook for each student in grades PK-12.
- Basic school supplies for preschool through grade 8.
- Books/workbooks for kindergarten through grade 5.
- The high school retreat for grades 9-12.
- Student activity fees for daytime, academic activity-related costs that apply to all grades PK-12.
- Senior dues which offset the cost of graduation fees (individual orders or needs for graduation are at the expense of the senior).

FEES NOT INCLUDED IN TUITION:

- Textbooks /workbooks for grades 6-12.
- Co-curricular and overnight trip fees are assessed according to individual student participation in activities/class trips (e.g. chess club, band, athletics, performing arts, etc.)
- Special services fees (e.g. Encore, Directed Studies, Speech, Bus Transportation, The Zone, Eagle Adventure Zone After School Care) are assessed according to services received.

A non-refundable, non-transferable and unconditional application fee of \$75 is due with all new student admission applications.

If accepted, a non-refundable, non-transferable, and unconditional tuition deposit of \$750 will be required within 10 days of notification of decision to complete the registration process.

Monthly tuition payments, special services payments, and required fees are due by the designated due dates or a late fee will be applied to the account.

2021-2022 MPCS TUITION FINANCIAL CONTRACT TERMS OF ENROLLMENT

All tuition payments are payable on the dates specified by the payment plans described in the [2021-2022 Tuition Rates and Payment Plans](#) above. Accounts are delinquent if not paid by the **tenth of the month** (June-April, with no payment due in January) and will be assessed a **\$50 late fee for each student. Please note, the initial payment is due on June 1 and no later than June 10 or a \$100 late fee will be assessed per student and the student may lose registered placement in a class.**

If an account falls 30 days past due, unless prior arrangements have been made with the Student Accounts Office and at the sole discretion of Mount Paran Christian School, the parents and/or guarantor may be contacted and the student may not be allowed to attend classes until the tuition is paid with an up-to-date status. The account will be subject to appropriate penalties, including all late fees which may have been forced to the extent permissible by law. There are no refunds given in the event of an act of God, government action, terrorism, or epidemic.

Any check or electronic payment returned for any reason will incur a \$30 fee. If returned a second time or if at least one prior check has been returned in this school year, full replacement payment by cash, credit card, cashier's check, or money order will be required within 10 days in order for the student to attend school. In addition, the family forfeits the right to pay any/all fees by check for the remainder of the school year.

Mount Paran Christian School must rely on tuition income to meet operating expenses. Since salary obligations are contractual in nature and are based on income projected by enrollment contracts, it is essential that the income from tuition be assured. If enrollment is cancelled or in the event of separation for any reason between the student and the school, other than the stated exception below financial obligations are as follows:

- IF ENROLLMENT IS CANCELLED IN WRITING PRIOR TO JUNE 1, 2021, the parents or guarantors forfeit the non-refundable, non-transferable \$75 application fee and the \$750 tuition deposit.
- IF ENROLLMENT IS CANCELLED IN WRITING AFTER JUNE 1, 2021 AND PRIOR TO THE FIRST DAY OF SCHOOL, parents or guarantors are obligated to pay 1/10 of the yearly tuition amount based on the ten-payment plan, and the forfeited non-refundable, non-transferable, \$75 application fee and the \$750 tuition deposit.
- IF ENROLLMENT IS CANCELLED IN WRITING ON OR AFTER THE FIRST DAY OF SCHOOL AND PRIOR TO THE END OF THE FIRST SEMESTER, parents or guarantors are obligated to pay for the entire first semester, and the 1/10 withdrawal fee based on the ten-payment plan rate of the annual tuition, and the forfeited non-refundable, non-transferable, \$75 application fee, and the \$750 tuition deposit. Any refund calculations for the second semester will be based on the selected payment plan as indicated on this contract and payments made toward the balance.
- IF ENROLLMENT IS CANCELLED IN WRITING ANYTIME WITHIN THE SECOND SEMESTER (from the first day to the last day), parents or guarantors are obligated to pay for the entire school year.

*The only exception to tuition payment policies is written confirmation from an employer indicating involuntary relocation of a family out of the Metro Atlanta Area. Under this exception a withdrawal fee of 1/10 of the yearly tuition, based on the student's selected payment plan and tuition for days attended, will be assessed. The tuition deposit (\$750) is non-refundable, non-transferable and unconditional without exception. In addition, students and parents are subject to all financial rules and regulations of the Parent-Student General Handbook.

- New student applications are to include the payment of a non-refundable, non-transferable application fee of \$75.
- New student tuition deposits are non-refundable, non-transferable, and unconditional without exception.
- Returning student applications are to include the full payment of a non-refundable, non-transferable, unconditional tuition deposit of \$750 in order to apply for the 2021-2022 school year. Priority is given for returning students through January 31, 2021.
- All students must have a FACTS tuition payment plan set up at the time of re-enrollment or within 10 days of new enrollment (and prior to school attendance). Enrollment is not considered complete and the student will not be placed on a roster without paid tuition deposit and FACTS payment plan setup.
- The \$750 tuition deposit for new and returning students will be applied to the total annual tuition balance.
- Returning students must register by January 31, 2021 in order to register with returning student status and avoid new student application fees. After February 1, 2021, returning student applications will be considered past due and as such will be changed to new student status and will incur an additional \$75.00 application fee at the time of re-enrollment.
- This contract includes agreement to all policies listed in the Parent/Student General Handbook and special service contracts.
